Working alongside our passionate Wilder learning Officers, you will be mentored under the support of a Wilder Learning Lead in the delivery of formal and informal outdoor education and play.

During the internship, you will be involved in the planning and delivering of events including evaluating for financial and impact reports and ensuring continuous development and improvements to the programmes.







This internship is well suited to those who are looking for a career in outdoor learning and education (in all weather). It is essential that applicants hold a BSc Degree or HND in Ecology, Conservation, Environmental or related fields (or equivalent) and is passionate about wildlife, nature and providing age-appropriate engaging activities within a safe environment for a charity that protects wildlife for the future and people of Essex. A Forest School qualification is desirable.



# Job Description

- To work with the Wilder Learning team to deliver activities for the Trust's Wilder Learning provision, including Nature Tots, the Wilder Schools Programme, after school clubs, parties, school holiday activities for children and families, and the Wild Living Programme.
- Work closely with the Wilder learning area team to ensure that budgets are maintained and managed, and income and delivery targets are met or exceeded.
- Ensure that all activities run in accordance with the appropriate policies, procedures, and practices, ensuring that all activities are risk assessed and health and safety compliant, demonstrating the highest levels of professionalism.
- Carry out any necessary administrative aspects of operations, including managing resources and general housekeeping.
- At all times be a reflective practitioner, evaluating your work in the spirit of continuous improvement, ensuring that the needs of participants and partners are met or exceeded.
- Demonstrate and develop skills, attitudes, and behaviours in line with the Trust's Competencies Framework.
- Undertake training such as first aid, safeguarding and play-based wildlife courses in order to develop skills and competencies to deliver a safe and effective programme.
- Work with the Wilder Learning team to deliver programmes across all age groups, targeted according to the Trust's priority audiences, with 'Wildlife for all' at the heart of delivery.
- As appropriate, deliver activities within the Trust's growing portfolio of county-wide education-focused engagement projects.

- A Forest School qualification (desirable).
- Has an interest in wildlife conservation, environmental science, and/or horticulture.
- Has an interest in formal and informal education and play.
- Has highly developed problem-solving and analytical skills.
- Is proficient with IT including using Microsoft Office.
- Can collaborate with other teams and departments to deliver greater impact.
- Follows current affairs, particularly in the environmental and education sectors.
- Is flexible and willing to support out-of-hours demands as and when required.
- Has the ability to work under pressure.
- Has interest in delivering programmes of education delivery connected to wildlife and nature.
- Can demonstrate excellent verbal and written communication skills.
- Has excellent attention to detail.
- Possesses good organisational skills and the ability to handle multiple projects.
- Is proactive and enthusiastic.

#### Additional Information

- The role will be working outdoors in all weather conditions.
- The role may entail some evening and weekend working.
- The role requires an interest in working for a charity that is determined to protect wildlife for the future and for the people of Essex.
- The role requires the ability to drive, including a full driving licence and use of a vehicle, though pool vehicles may sometimes be available.
- The post holder has a responsibility to safeguard and promote the wellbeing of children and young people.



### **Terms**

The position will be based at Langdon Nature Discovery Park with delivery at sites across Mid and South Essex. The starting salary is £22,308 per annum.
